The libary has an updated collection of approximate by 7200 books, which include wide range of textual and reference materials falling in the discipline of education viz. The Mother, Indian culture etc. Continuous efforts have been made for last three years to enrich the library with different books. Apart from books in library, we subscribes a variety of popular magazines, journals and daily newspapers in Hindi & English. At the functional level all attempts are made to acquaint the users with the library collection, different units of library, scheme of classification of books, shelf arrangement and methods to use the library catalogue. A library to be managed successfully and effectively requires certain rules to be followed strictly by the users. A copy of rules governing this library is made available to all students at the time of acquiring membership.



Infrastructure



COMPUTER LAB:

To keep the Pupil-teachers abreast with the latest technological development in the field of Education, we have made computer education as an integral part of curriculum. The computer laboratory is well versed with the latest computers, printers and internet connectivity. The college provides free use of this facility to all the students during the teaching hours. This facility has been added to the library with the purpose of getting



instant access of any subject from any part of the world. This is of immense help to both the student as well as the faculty to get any updated information around the world.



LABORATORIES:

The college is well equipped with different laboratories for use of students under the supervision of respective teachers. There is a provision for Work Experience room. Students are required to make adequate and proper use of these facilities. Certain rules for use of laboratories are to be followed:

- 1. To respect all materials of the laboratories and take a special care of apparatus/enquipments.
- 2. To remain silent and focused while working in laboratories.
- 3. All necessary precautions should be taken while using burner, electric points and gas.
- 4. Laboratories are meant to be learning spaces. No student can use the laboratory and computer in absence of teacher.

FIRST-AID ROOM:

First-aid facilities shall be available at the college campus. Students in need of further medical treatment will be taken to the nearest hospitals and parents/guardians will be informed.

TRANSPORT:

The institute is providing transport facility to students of surrounding areas.

POWER BACKUP:

The institute has a 165 KV generator sets, which provide 100% power back-up to classrooms & labs.



SPORTS & EXTRA-CURRICULAR ACTIVITIES:

A sports ground is available. It handsomely meets the requirement of extra curricular activities.

Rules and Regulations of the college



PROHIBITION AND PUNISHMENT FOR RAGGING:

Ragging in any from is strictly prohibited within the premises of the college.

CANCELLATION OF ADMISSION:

- 1. If a student remains absent for continuous 4 days or more without intimation.
- 2. She has irregular attendance.
- 3. Non-Payment of tuition fees/dues.
- 4. Breaking of rules and regulations.
- 5. If She does not join the particulars programme by stipulated date even though the fees has been deposited.

 The decision of the administration shall be considered final.
- 6. In case of creating any indiscipline.

RE-ADMISSION:

If a student remains absent for four days or more in a month then his name will be struck off from the rolls and readmission will be allowed for only after submitting an affidavit of not repeating the same in future along with Re-Admission Fee.

UNIFORM CODE:

There is a uniform for the pupil-teachers which is must to wear while coming to college:

Summer:

White Suit & Salwar and Maroon Dupatta.

Winter:

White Suit & Salwar with Black Sweater and Maroon Dupatta.

VISITING RULES:

No visitors will be allowed to contact any student without the prior permission of the Principal. Parents may meet the principal with prior appointment on all working days.

TIMING:

The college is open on all working days. Working hours are 9.00 a.m. to 4.00 pm.

Rules and Regulations of the college



The student studying at S.L.D. Girls College of Education are embarking upon professional life in due course of time. In order to foster a sense of responsibility and discipline in our student a special code of conduct is expected of them in all their activities at the college.

- Every student of the college is issued an Identity Card which she is expected to carry with her at all times.
 She will have to produce it whenever demanded. The Identity Card must be surrendered at the time of leaving the College.
- 2) Students are responsible for their conduct to the Principal and are prohibited from doing anything either inside or outside the college that will amount to a breach of discipline or interference in the discipline and normal working of the college. A student shall be liable to disciplinary action for violation of any of the rules of discipline. Disciplinary action may involve warning, and/or suspension from classes, from the examination, from use of the College Library or even from the College.
- 3) Students shall conduct themselves in a polite manner both towards the members of the staff (teaching and administrative) and towards their fellow students. Insubordination, unbecoming language or ungentlemanly conduct including teasing etc. shall be severely dealt with.
- 4) Students shall maintain perfect silence in classrooms and desist from demonstration of disorderly behavior. They must not loiter in the corridors or in front of classrooms or office rooms and must keep as quiet as possible at all times. During their free periods, students should work quietly in the library or reading room or spend the time without causing any disturbance.
- 5) Students shall take proper care of the College property, furniture and premises and they should not spoil or cause any damage or tamper with College property, furniture and fittings. No furniture can be brought out of rooms without the permission of competent authority, violation of this can lead to serious discipline any action.
- 6) 95% Attendance of the pupil-teacher is compulsory.
- 7) To participate in various curricular activities and function of the college is compulsory for all students.
- 8) All the students must observe punctuality. We are very particular on attendance in the Morning Assembly, the absence in morning Assembly, will be considered as absent for the whole day.
- 9) Pupil teacher are required to come in proper uniform, which will be available from the college itself or from can be purchased from market.
- 10) A student will be allowed to take a leave for maximum of two days in a month.
- Students are supposed to submit leave application for their absence. We shall debar the student from examination who fall short of prescribed attendance. In case of illness, students are supposed to submit a medical certificate along with the application. Spurious certificate shall be rejected.
- 12) Any absence, without sufficient and valid reason, fine will be charged. The imposition of fine is a tool to bring about regularity in attendance. A maximum of two days leave will be allowed in a month.
- 13) 100% attendance in practice-teaching and internal exam is mandatory for all students.
- 14. The college is not responsible for loss of any valuable including money and mobile phones.
- 15. Use of mobile phones is strictly prohibited during college hours.
